

Coming Events



The Sidney and North Saanich Historical Society

The issue that concerns the Society, is the Sidney Museum which the Society thinks should be a designated heritage structure. It was built in 1939 of brick from the old Vancouver Hotel. This unique building served for many years as a customs house. It may be the only example of the drive-through design of customs house being used in another capacity, in this case as a museum. There are a few of this type of customs building still in use. The example in Sidney is well preserved. The planned developments at the Sidney waterfront threaten the museum. As there is considerable public unease, especially with the prospect of foreshore condominium buildings, the town is reluctant to clarify just what is planned, or will happen without plans. This threatens the museum which is located on the foreshore and is a juicy bit of property for a developer. The Society is therefore seeking Heritage status for this museum building. Last Fall, President Paul Convey asked member Al Fry to assess the Hallmark Commercial Building files. With Cadillac Fairview already destroying some downtown heritage buildings, it was felt that the files were in desperate need of attention. Many of these files were outdated with bad or no photographs. Al Fry submitted a full report on the files and recommended photographing approximately 150 buildings in the downtown and surrounding area. Regional Heritage News

The Regional Heritage Coordinating Committee meets every three months to foster communication and cooperation between heritage groups in the Capital Regional District. The most recent member of the committee is the Sidney and North Saanich Historical Society under the leadership of President, Don Robb. This Society acts as Heritage Advisory Committee to North Saanich Council.

The last meeting was held June 11, 1987. The next meeting will be held on September 24, 1987 in the Saanich Municipal Hall.

Victoria Heritage Foundation

The V.H.F. has been hard at work as co-sponsor of the 1987 A.P.T. Conference which is taking place as this Newsletter is mailed. It is sure to have been a smashing success!

The V.H.F. would like to thank the Hallmark Society for the extensive promotion of the conference in recent issues of the Hallmark Newsletter.

There have been fifteen new requests for designation to Victoria City Council, via the Heritage Advisory Committee. All fifteen are registered heritage houses, and had received a letter from the V.H.F, explaining the Foundation granting program and inviting them to inquire into designation. There are approximately 250 registered heritage houses in the City of Victoria.

Victoria Heritage Advisory Committee

At the meeting of August 17, 1987, the V.H.A.C. passed a recommendation to council that the C.P.R. Roundhouse Building, tracks and associated machinery, located at 251 and 253 Esquimalt Road, be placed on the Heritage Registry.

The V.H.A.C. presented a proposal to the Downtown Investment Fund Task Force, that a designated commercial building funding program be set up, utilizing \$800,000.00 of the \$1.6 million available in the fund from the sale of Broad Street to Cadillac Fairview Corporation. It was felt entirely appropriate that such a large portion of the fund should be designated for commercial heritage buildings as the Cadillac Fairview project is destroying ten prime commercial heritage buildings in the downtown core. It would be quite justifiable to spend the money on those buildings that are left.

Saanich Heritage Foundation

The Heritage Restoration Workshop for residents of Saanich, who own heritage buildings is going ahead on October 17th. The workshop is a pilot project and the B. C. Heritage Trust is sponsoring the developing of a guide and kit describing how to organize such a workshop. The guide will be available after the workshop and Heritage Trust will mail a copy to interested groups. For further information on the workshop, contact Bjorn Simonsen at 479-1147.

Saanich Heritage Advisory and Archives Committee

Three people will be hired through the Job Trac program to do archival work dealing with the history of Saanich.

The S.H.A.A.C. has received approval for a grant to continue with Phase 2 of the Saanich Buildings Inventory, which is being conducted by Hallmark Executive member, Jennifer Barr. The project is funded with the assistance of the Ministry of Tourism, Recreation and Culture of the Provincial Government, through the B. C. Heritage Trust.

On September 1, 1987, Saanich Council voted not to sell the Goward property. However, Council is encouraging a proposal by the Cridge Centre for developing the house and property as a family orientated residential and recreational development which would include the restoration of Goward House.

B. C. Historical Federation - Victoria Section

The Victoria Section has received a Job Trac grant to hire five people to research and conduct walking tours to Pioneer Square and Ross Bay Cemeteries and to enter the burial registers onto computer!
