

# A Home for Hallmark

#### Foster Isherwood

As our Society has literally gone from pillar to post, it now becomes apparent that we should have housing of our own. The old days of saving space and making do in quarters that were not ours should now be in the distant past.

To find a structure - most preferably a heritage house with a good enough profile, well located in a reasonable neighbourhood, which would allow us to pursue our activities, rent space to either a compatible business or provide good housing upstairs - should be our goal.

There are many such possibilities and locations in James Bay, Fairfield, Fort Street, Rockland, Spring Ridge and even the commercial fringes out to and including the Hillside, Saanich, Oak Bay and Esquimalt municipalities. These areas might have a suitable house on a location that would offer satisfactory accommodation and the most important ingredient—the restoration of a true heritage building for our own use and for the use of anyone associated with us.

The Heritage Trust grant, our present means of funding for this purpose, and an active membership which will be willing to pitch in numerous ways, can certainly make this possible. The special rights given to non-profit societies for gambling casino events could quite conceivably bring in between \$15,000 to \$20,000 over two years, which can be applied against capital expenditures and improvements on the society's property.

Let us all get our collective thinking caps on and think of possibilities. Whether they seem small or large, all potential ideas bear investigating. With your help, the Society could be moving in a positive way. Our watchwords should be Reassessment, Reappraisal, Relocation, good planning and Restoration. So keep your eyes and ears open!

Good news!! Although our pursuit of our own building is very much alive, we are nevertheless still active in obtaining a long-term lease for the South Park Annex. The Heritage Building Foundation and the Hallmark Society met on January 26 to begin negotiations for such a lease. We will keep you posted as the terms are defined.

We also look forward to the continued participation of several municipalities in designation ceremonies, when they acknowledge those whose properties have been designated during the past year.


The annual Jessie Woollett Photo Competition winner will also be presented with a \$50.00 cheque. For details on the competition, see the announcement on page 6.

# **Cover Story - Miraloma at Risk**

Currently before Sidney Council is the proposed development of the property known latterly as "The Latch" restaurant. Preliminary plans as presented to the Committee of the Whole on December 20, 1993 call for the retention of the Latch with its conversion to three condominium units. Public access will be retained, although how this will be achieved is not clear. Of grave concern is the proposal to erect a 3storey condominium containing some 26 units which would be sited at the East of the site. This location would greatly impinge on the view of the Latch from the public roadway. Although assurances have been given that the gardens will be restored, it is hard to equate the amount of green space which will be left after the addition of a new structure, retention of the main building and an additional structure - all on a site of 11/2 acres. The proposal has been referred to a joint meeting of the Heritage Advisory Committee and the Advisory Planning Commission.

The proposed development is not in line with the Official Community Plan and would require rezoning of the property. As this was Samuel Maclure's last large commission and perhaps his best example of house and garden as a cohesive unit, it is vitally important that this building and the small remnant of its grounds be saved. The provincial significance of the buildings, in that it was built for Walter Nichol, Lieutenant-Governor of the Province from 1920 to 1926, cannot be overlooked. In 1925, Maclure was asked by Nichol to design a summer residence in Sidney which would express its local character by using a variety of British Columbia woods. Named Miraloma, it was sited amid acres of meticulously landscaped gardens overlooking the sea and contained buildings which were treated as landscape features: a 20' x 30' summer house, a garage with chauffeur's quarters, and a dance pavilion, including mens' and women's cloakroom,





toilets, and a huge inglenook fireplace. The major feature of the 15-acre site remained its heavily wooded natural state, which combined the mature growth of trees with the ever changing carpet of wild flowers on the woodland floor. Maclure created a thoroughly rustic exterior by facing it with slabs of fir with the bark still on. Tree trunks of different heights and girths formed columns, brackets and verandah railings. Enormous, bark-clad slabs of the same fir, requiring ten men to hoist them into place, were used as barge boards under the gabled eaves. The interior panelling, in a variety of woods, fir, cottonwood, spruce and beech, stained to produce some exceptional effects, is unusually fine. George Gibson, a craftsman from Shawnigan Lake, carved three staircase ornaments: a bulldog, a monkey and an owl, all of dogwood.

Samuel Maclure was born in Matsqui in 1860, the son of a Royal Engineer. He was self-trained as an architect and studied architectural drawing in Philadelphia. He strived for total satisfaction in the work he did. One-third to one-half of all buildings he designed are still there. He is best known for the Tudor Revival and Craftsman styles, which he modified to his own tastes. The interiors were generally impressive, with built-in china cabinets and sideboards. As in Miraloma, he preferred to use local woods in halls. In 1979, a Hallmark Society Award of Merit was presented to Fred Oldfield and Robin Thompson who had converted the rustic log home to "The Latch" restaurant without destroying its character. Although the list of extant Maclure buildings in the Capital Regional District is impressive, we must not lose sight of the fact that Miraloma is the largest heritage property in the Sidney area and as such is worthy of our efforts to ensure it retains the characteristics for which Maclure was known. We will be continuing to follow this matter through Sidney Council with great interest.

### **Hagan House Designated**

On November 13, 1993, the Hagan House became the first house to receive heritage designation in the Municipality of Central Saanich. It was threatened with demolition in 1989 due to a Central Saanich bylaw which prohibited two dwellings on the same parcel of land. The current owners, Mr. and Mrs. Ron George, argued that as the building was built long before zoning regulations and has formed an itegral part of the whole property for many years, it could be considered a guest house and would

therefore not contravene the bylaws. Due to tremendous efforts by the Central Saanich Heritage Advisory Committee, Council, Saanich Pioneers Society, the Hagan family and the Georges, this important piece of history has not only been saved, but it has been completely updated and now stands prepared to last another century.

The original owner of the land, Angus McPhale, squatted in this area from 1855.

Receipt 1156 by J.D.Pemberton shows pre-emption of Sections 5 and 6, Range II West by Angus McPhale on July 2, 1859. Within the next three years, this land was sold to Alphonse Verdier, except a 25 acre parcel which McPhale sold to Peter "Lutton". This was actually Peter Lind, who built a 30' x 30' two-room log cabin in 1862. On May 18, 1864, Peter Lind and his new bride opened the "South Saanich Hotel" in that cabin. It was a popular stop-over point for visitors to the Peninsula. The Hotel was sold to Robert Porter in 1865 who operated the hotel with his partner, Hillier. At this time the first regular ferry service between Cowichan and Saanich was established, with the landing site just west of the hotel along Hagan Bight.

In 1867, the hotel was sold to Alphonse Verdier. By 1872, James Hagan had purchased the property as a homestead for his young family. An 1893 photograph shows a new front addition on the log cabin, added in 1872, to provide space for his wife and small son. In 1894, James Hagan donated land to the Catholic Church, upon which Father Vullinghs built the Church of Our Lady of the Assumption. It is due to Father Vullinghs that many photographs of the area are to be found. Rumor has it that he also provided the walnut tree which now stands over 75 feet tall in the yard of the Hagan House. Between August 1, 1892 and May 31, 1913, a post office was operated out of this house, with Hagan acting as the Postmaster. Upon James Hagan's death, son

Lawrence (Larry) remained on the site and continued to farm the land with his sisters. Larry Hagan was a prominent citizen of the community, having served as councillor of Ward 6 for 21 years, as a school trustee and was a founding member of the Saanich Pioneer Society.

In 1944, Colonel W.C. Woodward purchased the Hagan property upon Larry's death and subsequently utilized the house as a herdsman's cottage. The property soon became a part of the Woodwyn Farm.

This Victorian style farmhouse, typical of its era, remains on its original stone and mortar foundation. Modifications reflect the various functions served over the years, but the essence of the original dwelling is still very evident.

Original 8" by 14" beams, span 25' and can been seen from the crawl space. Hand hewn, they are believed to have been cut by John Otto, a well known pioneer area craftsman. The main floor living area is surrounded by wainscotting, with tongue-and-groove fir floors throughout. Doors represent many styles, from rough planking to the 1940s. Many changes have been made: the present kitchen, bedroom, darkroom and bathroom occupy the original log cabin. The area of the 1872 addition is a 16' x 34' living space, and a 16' x 20' bedroom upstairs used to be Councillor Hagan's. A spacious hallway, turns to the west into the rear bedroom, which has one of the best views in the area. The exterior is completed with 8" drop siding.

All donations are tax-deductible too, so everybody benefits! Please send the form below along with your contribution to help Hallmark Society achieve our common goal.


