These problems seem to be on their way to solution, and we look forward to announcing concrete plans in the

near future. Jim Lee and John Keay are working on a \$40,000 loan from CMHC for conversion of the Jackson House. Tom Mayne is submitting a lotteries application to help raise funds for the house.

### STUART GOES TO WINNIPEG

Stuart reported good contacts made at the Heritage Canada Conference in Winnipeg in October. He extracted a promise from a Bank of Montreal representative who spoke at the conference, to halt renovations on the Douglas & Yates bank building. They were applying a waterproof coating which will cause the facing stone to rot. It has been noted with dismay, however, that said work is continuing, and a letter of protest is being sent to the bank. Stuart was out-ofpocket over \$700 as a result of attending the conference, and the Executive voted to reimburse him for \$100 of that amount.

### **BAZAAR RETURNS**

The Annual Bazaar held at Hillside Mall on October 23rd netted \$310. Thanks to Isla Tuck who organized the event, and to all those who in any way contributed toward it.

### NEW MEMBERSHIP CATEGORY

# TRUTCH TROUBLE

Stuart Stark and Peter Walton were asked to attend a meeting regarding a developer's proposal for 601 Trutch Street and the two adjoining houses to the north. The Trutch House (Fairfield House) was listed as of primary importance in the City's Heritage Conservation Report, "This Old House", along with the entire street, a basically intact 1906 subdivision. Both Stuart and Peter were astonished that anyone should so blatantly disregard the City's own report and come up with a proposal of this kind. It is not a bad proposal in itself, but simply should not be entertained on a street of this importance. Fairfield House is one of the three or four most important houses in the entire city, and even served as Government

House during the renovation of Cary Castle. Be prepared to write letters in support of retaining the Trutch Street Cluster, as plans become more evident. Approval seems to be coming from levels which should be heeding, rather than ignoring, the City's report.

The Heritage Conservation Branch has asked the Hallmark Executive to come up with ideas for use of the Emily Carr House, so please let us know your thinking on this.

# MONDAY URBAN CONFERENCE

John Keay and Stuart Stark represented the Hallmark Society at this conference held in October at the Empress. No decisions were made, but it was encouraging to note a wide range of support for Victoria's more obscure attractions; even businessmen were fed up with the continuing desecration of Beacon Hill Park, for instance.
