## JUNE 1981 NEWSLETTER

JACKSON The long-awaited completion of renovations on the Jackson House is imminent, and you are invited to an OPEN HOUSE, from 10 a.m. to 4 p.m. on Sunday, July 12th. It will not be the grand opening originally envisaged, as there has been a delay HOUSE 425(?) PARRY ST. in designating the house as a heritage dwelling, partly due to the recent civic strike. As a result, the grant money which was to be used for painting will not be forthcoming in time to complete painting. For a number of reasons, not the least of which is that Stuart is leaving, it was deemed important to have the opening in early July, so we're painting a sample area to show the colour scheme that will be used. Contributions will be accepted toward the painting, landscaping and other work still to be done. There is a shortfall of approximately \$5,000-\$7,000 in renovation funding.

RICHARD CARR HOUSE 207 GOVT.


One of the BIG items discussed at the General Meeting on June 2nd was the offer by the Heritage Conservation Branch, Ministry of Provincial Secretary, to lease to the Hallmark Society on a long-term \$1 per year basis, the top floor of the Richard Carr House, Emily's birthplace! This was a rather unexpected happening, although the Society had earlier made recommendations, at the request of the Heritage Conservation Branch, as to usage of the building. We had suggested a museum-type use, so as to conserve the building. The deal now is that only the two front rooms on the first floor, plus the garden, are to be restored.

This development opens up many possibilities -- among which are creating a tidy income for the Heritage Building Foundation by providing volunteer tour guides and running a gift shop and tea room on the premises. This, of course, would require great commitment from member volunteers, and so is a big decision. There is also the possibility of simply making like tenants on the top floor and going about our usual business from that location instead of the Jackson House. And of course, this would mean adding another room to the rental accommodations in the Jackson House.
